GEDA had invited EOI for empanelment of additional Channel Partners for the implementation of aforesaid scheme.

We are pleased to inform you that your company has been empaneled by GEDA to implement the above scheme. You shall identify and motivate beneficiary, design the system with all accessories and equipment supply, Install, Commission and Maintain for 5 years with free replacement of guaranteed parts against manufacturing defects including obtaining necessary approvals from GEDA, concern DISCOM and Chief Electrical Inspector (CEI) for the Residential Rooftop Solar Systems in the state at a rate Rs. 69,000/-- per kilowatt (Sixty Nine thousand only) as per the specifications , terms and conditions accepted by you in the EOI and those mentioned below.

The above price shall be **EXCLUSIVE** of fees / charges such as security deposit payable to office of DISCOM etc.

### Terms and Conditions:

1. The above rate is inclusive of the State Subsidy & MNRE subsidy, all taxes, insurance, transportation, installation, commissioning and maintenance of system for five years at any given site in Gujarat.
2. The state subsidy @ Rs. 10,000/- per kW with a ceiling of Rs. 20,000/-- shall be reimbursed upon successful commissioning of the system.
